Writ Petition is filed under Article 226 of the Constitution of India, praying this Court Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the respondents herein to take necessary and immediate action for shifting the Bus Stop which is situated in S.No.32/1 Opposite to Meenakshi Mission Research Hospital, Madurai to a distance of 50 meters in due compliance of the proceedings issued by the District Collector, Madurai vide proceedings vide O.Mu.No.16523/2021-C5 dated 07.06.2021, proceedings of the Assistant Executive Engineer, PWD Periyar Main Channel, Sub Division No.1 Madurai also sent a letter to the Engineer, Madurai Corporation, Thallakulam in Letter No.Nfh.21/2023/cnr.ngh1 dated 10.05.2023 and also proceeding issued by the 3rd Respondent sent to his higher official viz. The Commissioner, Traffic and Investigation, vide his proceedings dated 28.04.2021 and by considering the undertaking given by the petitioner in this affidavit to bear entire costs of demolition of existing bus stop and construction of new bus stop.
