The learned Government Advocate (Criminal Side) appearing for the respondents no.1 to 4 would submit that there is a dispute between the petitioners and the respondents no.5 and 6 in respect of tenancy dispute and the enquiry is pending. For enquiry purpose, they called the petitioners and the 4th respondent has not harassed the petitioners as alleged by them and they will complete the enquiry within one week.
