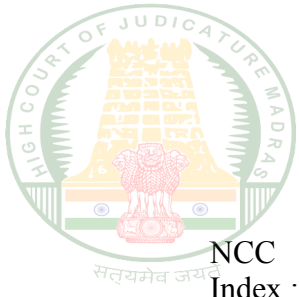
2. The petitioner, with a grievance that he has not committed any offence, has filed this petition to quash the proceedings pending against him in C.C.No.10 of 2023.
