ORDER

WEB COPY This Criminal Original Petition has been filed to quash the First Information Report registered in Crime No.85 of 2023 on the file of the first respondent Police Station.

2. The allegation in the FIR is that the petitioner rode the two wheeler in a rash and negligent manner with the victim seated as a pillion rider; and that the petitioner lost control of the vehicle, as a result of which, the victim sustained injury and thus, committed the aforesaid offences.

3. Admittedly, the petitioner and the respondent Nos.2 and 3 have now entered into a compromise and decided to give a quietus to the entire dispute. The parties have filed a joint compromise memo and the scanned copy of the compromise memo reads as follows:

injuries to his left shoulder and arm. The petitioner also suffered a bleeding injury on the left side of his head and nose, along with abrasions on his left hand. The 2nd respondent immediately rushed to the scene and, with help from bystanders, took both of them in his auto-rickshaw to Tirunelveli Government Hospital for treatment. Based on the 2nd respondent's complaint, the 1st respondent police registered the case on 31-05-2023 in crime No.221 of 2023 for the alleged offence punishable under Section 279, 308(ii), 337 of IPC and Section 184, 185 of Motor Vehicles Act.

3. It is submitted that the petitioner and the respondents 2 & 3 have resolved all the disputes between them. So, the case in crime No. 221 of 2023 on the file of the 1st respondent police for the alleged offence punishable under Section 279, 308(ii), 337 of IPC and Section 184, 185 of Motor Vehicles Act is unnecessary and the same has to be quashed in the light of the circumstances stated in the affidavit enclosed herewith and this Hon'ble Court may be pleased to pass suitable orders and thus render justice.

The petitioner, namely, Parthasarathy.V.K (Aadhaar No.9821 8331 8578), second respondent, namely, Syed Noor Mohammed (Aadhaar No.3902 2998 6781), third respondent, namely, Syed Rizwan.S (Aadhaar No.2627 7500 7119) are present before this Court in person and identified by Mr.Arumugam, Special Sub Inspector of Police, TIW-Tirunelveli City. All the parties confirmed the compromise arrived at between them.

5. In view of the same and considering the nature of the offences and the relationship between the parties, this Court is of the view that no useful purpose would be served in keeping the impugned FIR pending investigation. Accordingly, the impugned FIR in Crime No.221 of 2023, dated 31.05.2023 is quashed and the Criminal Original Petition stands allowed. The petitioner shall pay a sum of Rs.5,000/- (Rupees Five Thousand only) as costs to the High Court Legal Services Authority attached to this Bench forthwith and file a photocopy of the receipt along with a memo reporting compliance in the Registry.
