2.The appellant herein had filed W.P.(MD)No.9272 of 2024 assailing the appointment of one Aruna as Assistant Programmer. The writ petition came to be dismissed on 16.04.2024. Challenging the same, this writ appeal has been filed.

3.The learned counsel for the appellant states that the issue is yet to attain finality. He also realizes that the writ petition should not have
