ORDER : The Court made the following order :-

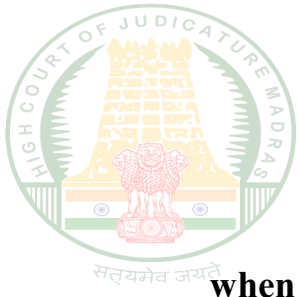
This petition has been filed to relax the condition imposed on the petitioners in Crl.O.P.(MD).No.12192 of 2025 dated 04.08.2025. .
