ORDER : The Court made the following order :-

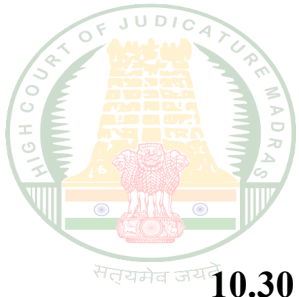
This petition has been filed to relax the condition imposed on the petitioners in CrI.O.P.(MD).No.13393 of 2025 dated 12.08.2025. .
