**PRAYER:** Writ Petition filed under Article 226 of the Constitution of India for issuance of Writ of Mandamus, to direct the respondents to consider the representation dated 01.09.2022 and to conduct re-survey and demarcate the land to an extent of 129 sq.meter (1.29 Ares) comprised in S.No.62/13 at Pudhupattinam Village, Thiruvadanai Taluk, Ramanathapuram District and fix the boundary stones in the petitioner's land within the time frame as may be fixed by this Court.

**ORDER**

Considering the limited scope of the relief sought for by the writ petitioner, this writ petition is taken up for final disposal.

The petitioner has made an application for surveying of his land on 28.02.2022 and being dissatisfied with the manner in which the survey was conducted, he made a fresh application on 11.04.2022 after paying requisite fee for re-survey. Thereafter, the petitioner had given a representation on 01.09.2022 in furtherance of his application on 11.04.2022. The petitioner seeks expeditious disposal of his application dated 11.04.2022.

3. Considering the limited scope of the prayer sought for by the writ petitioner, the third respondent shall conduct re-survey and demarcate the petitioner's land measuring 129 sq.meter (1.29 Ares) comprised in S.No.62/13 at
