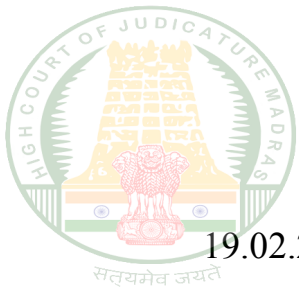

ORDER

This petition has been filed by the petitioners to call for the records pertaining to the First Information Report in Crime No.27 of 2024 dated 21.10.2024 on the file of the first respondent police, for the offences under Sections 498(A), 354, 506(i) and 406 IPC and quash the same.

2. When the matter was taken up for hearing, the learned counsel on both sides represented that the matter has been amicably settled between the parties and to that effect, they have entered into a compromise and the same was filed before this Court.

3. The defacto-complainant and all the petitioners accused are present and this Court enquired about the terms of compromise. The defacto-complainant represented that they entered into a compromise and he has no objection to quash the FIR. A compromise memo, dated

5. Considering the nature of the offences and the parties have also entered into a compromise, it is appropriate to allow this petition.

The compromise memo dated 19.02.2025 filed by the parties shall form part of this order. Consequently, connected miscellaneous petition is closed.
