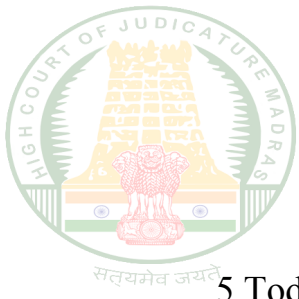
3.The Criminal Revision Case is filed with the following prayer:-

“to set aside the judgment passed in Crl.Appeal No.117 of 2018 dated 19.06.2025 on the file of the Sessions Fast Track Mahila Court, Kanyakumari at Nagercoil, confirming the judgment in STC.No.602 of 2018, dated 24.07.2018 on the file of the Fast Track Court, (Judicial Magistrate Level), Nagercoil.”

4.The Co-ordinate Bench of this Court, vide order dated 25.08.2025, in Crl.R.C. (MD) No.1142 of 2025 had passed the following order:-

“The petitioner is directed to pay 10% of the compensation amount to the credit of STC.No.602 of 2018 on the file of the learned Fast Track Court, Judicial Magistrate Level, Nagercoil, on or before 17.09.2025.

5.Today, when the matter is being taken up, Mr.R.Jegadeeswaran, learned counsel for the petitioner, prays this Court to grant some further time to the petitioner to make compliance of the order passed by the Co-ordinate Bench of this Court in Crl.R.C.(MD) No.1142 of 2025, dated 25.08.2025.

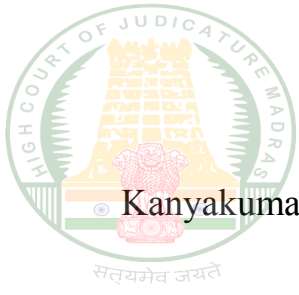
7.Put up the Criminal Revision Case 'for orders' on 23.10.2025 before the appropriate Bench.
