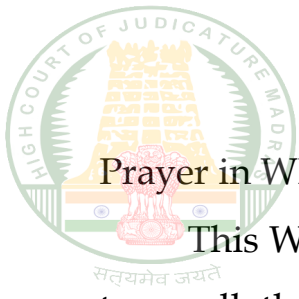

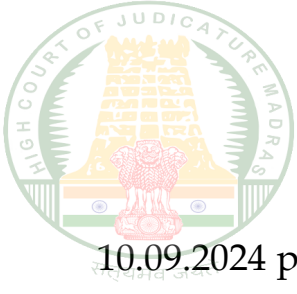
Prayer in WMP(MD). No.25027 of 2024:-
