In view of the above, it is left open to the defacto complainant to file a memo before the Court below and seek for withdrawal of the sum of Rs.2,50,000/- which has been deposited to the account of Crime No.261 of 2024. The Court below shall entertain the same and permit the defacto complainant to withdraw the amount. It is made clear that the withdrawal of the amount and the payment to the defacto complainant is without prejudice to the rights of the petitioner.

6. In view of the above, CrI.M.P.(MD).No.13271 of 2024 is disposed of, since the amount has been deposited.

7. In so far as CrI.M.P.(MD).No.13503 of 2024 is concerned, the petitioner was directed to deposit his passport as per the condition 6(c) of the order.

8. In the light of the above development and taking into consideration the fact that the petitioner has to undergo higher education in a foreign Country, the said condition stands deleted. To that extent, the CrI.M.P.(MD).No.13503 of 2024 stands allowed.
