2. Heard the learned counsel appearing for the petitioner and the learned Special Public Prosecutor for CBI cases appearing for the respondent.

Considering the above, the condition No.14(ii) imposed on the petitioner in CrI.M.P.(MD)No.8193 of 2025 in CrI.A.(MD)No.708 of 2025, dated 03.07.2025 is modified to the effect that the petitioner shall report before the CBI Court, Madurai, at 10.30 a.m. on the first working day of every month until further orders. All other conditions in the said order shall remain unaltered.
