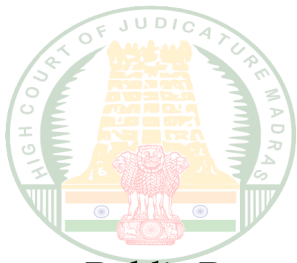
Prayer :-
