ORDER : The Court made the following order :-

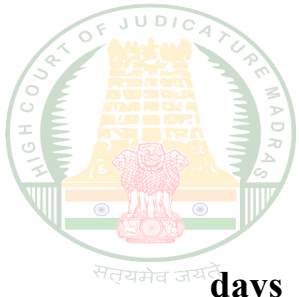
This petition has been filed to relax the condition imposed on the petitioner in Crl.O.P.(MD).No.13955 of 2025 dated 26.08.2025.
