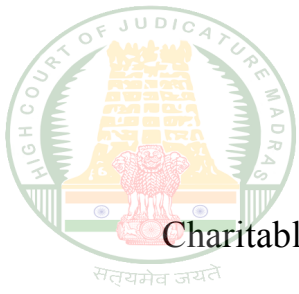

2.The writ petitioner herein suffered an order under Section 78 of the Tamil Nadu Hindu Religious and Charitable Endowments Act. Challenging the order dated 05.02.2025 passed by the Joint Commissioner, Hindu Religious and Charitable Endowments, Tirupur, a revision has been filed before the first respondent under Section 21 of the Hindu Religious and
