ORDER

This Criminal Original Petition is filed seeking to quash the FIR in Crime No.422 of 2021 on the file of the first respondent, which was registered for the offences under Section 296(b), 323 and 506(2) of IPC.

2. The allegation in the FIR is that on account of prior enmity, the petitioner had abused the victim in filthy language and also assaulted him besides committing the offence of criminal intimidation.

3. Admittedly, the petitioner and the respondents 2 and 3 belong to the same Village and they have now entered into a compromise and decided to give a quietus to the entire dispute. The parties have filed a joint compromise memo dated 21st July 2025 and the scanned copy of the compromise memo reads as follows:

JOINT MEMO FOR COMPROMISE

1. It is submitted that the Petitioner prefers this memorandum of Criminal Original Petition for quash and praying that this Hon'ble Court may be pleased to call for the records of impugned First Information Report in Crime No. 422 of 2021 on the file the Respondent No.1 Police Station and quash the same as illegal. Since due to wordy quarrel between Petitioner and the Respondent Nos.2 & 3 this case has been registered and now the Petitioner and the Respondent Nos.2 & 3 proposed to compromise and settled their disputes with amicably before their elders and family members and the Respondent No.2 is not willing to prosecute the case as against the petitioner.
2. It is submitted that the prosecution case is that on 25.08.2021 the Respondent No.1 received a complaint from the Respondent No.2 and gave CSR No.302 of 2021 and after the enquiry, on 30.08.2021 at about 10.16 hours he registered this case base on the complaint of the Respondent No.2 wherein he stated that as he is residing in the above said address. The Respondent No.3 who is the uncle of the Respondent No.2 is residing with him. On 25.08.2021 at about 11.30 AM while the Respondent No.3 came to his home, the Petitioner waylaid in front of his house, abused him with filthy language with stating that as your sister Rabiya restrained me through Police for installing camera and assaulted him with iron rod and camera wire. Immediately the Respondent No.2 rushed to the spot at the time the Petitioner criminally intimidated him with dire consequences by showing Arival and flee away from the spot, then the Respondent No.2 hospitalized

the Respondent No.3 in Manamakkudi GH and then lodged this complaint before the Respondent No.1 Police Station and this present case has been registered for the alleged offences under sections 294(b), 323, 506(ii) of IPC.

3. It is submitted that the at this juncture the Petitioner and the Respondent Nos.2 & 3 were settled their disputes amicably before their elders and family members and the Respondent No.2 do not want to continue the criminal proceedings against the Petitioner.

4. It is submitted that in these circumstances the petitioner is having no other alternative effective and efficacious remedy except to approach this Hon'ble court by invoking the inherent power of this Hon'ble Court conferred under section 528 of BNSG to quash the impugned First Information Report in Crime No. 422 of 2021 on the file of the Respondent No.1 Police Station

Therefore it is most respectfully prayed that this Hon'ble Court may be pleased to record this compromise memo and pass such further or other orders as this Hon'ble Court may deem fit and proper in the circumstance of the case and thus render Justice.

4. The petitioner, namely, Kalil Rahman @ Kaleel Rahman (Aadhaar No.6507 8975 2766), the defacto complainant, namely, Ajimal Khan (Aadhaar No.4134 2995 2348) and the victim, namely, Kalil Rahman (Aadhaar No.2825 3032 1816) are present before this Court in person. They are identified by Mr.V.Krishnan, Sub Inspector of Police, Mimisal Police Station, Pudukkottai District. All the parties confirmed the compromise arrived at between them.

5. In view of the same and considering the nature of the offences and the relationship between the parties, this Court is of the view that no useful purpose would be served in keeping the impugned FIR pending investigation. Accordingly, the impugned FIR in Crime No.422 of 2021 on the file of the first respondent is quashed and the Criminal Original Petition stands allowed. The petitioner shall pay a sum of Rs.5000/- (Rupees Five Thousand only) as costs to the Mediation and Conciliation Centre attached to this Bench forthwith and file a photocopy of the receipt along with a memo reporting compliance in the Registry.
