ORDER

Recording the above submission, this Court directs the third respondent to complete the enquiry and communicate the result of the enquiry to the petitioner within a period of one (1) week from the date of receipt of copy of this order. It is needless to say that the respondents Police shall not harass the petitioner under the guise of enquiry based on the repeated complaints of the fourth respondent.
