COMMON ORDER

2. The case of the petitioner is that the orders black listing the petitioner for a period of 3 years from the list of Arasu Rubber

4. In view of the above, all the Writ Petitions stand disposed of. No costs. Consequently, connected Miscellaneous Petitions are closed.
