ORDER

This Writ Petition is filed seeking Writ of Certiorari to call for the records pursuant to the impugned order of suspension dated 28.08.2025 in Na.Ka.No.A7/1075/2025 passed by the 3rd respondent and quash the same as illegal and consequently direct the 3rd respondent to reinstate the petitioner in his service as sales men in TASMACH Shop No.10891, situated at Rayagiri Village, Sivagiri Taluk, Tenkasi District with all attended benefits.

2. This Court has considered the submission of learned counsel on either side and perused the materials available on record.

3. It is brought to notice by the learned counsel for the respondents that the enquiry had been completed and report has also been received from the enquiry officer. Second show cause notice is to be issued to the petitioner calling for his further explanation.

4. In such view of the matter, there shall be a direction to the third respondent to bring the disciplinary proceedings initiated against the petitioner to its logical conclusion within a period of four months from the date of receipt of a copy of this order.

5. Learned counsel for the petitioner would submit that the subsistence allowance has not been paid.

6. The respondents are directed to pay subsistence allowance as provided under law to the petitioner. It is made clear that if subsistence allowance is not paid to the petitioner, the disciplinary proceedings initiated and any order passed thereon, should be set at naught, for non-payment of subsistence allowance.

7. With the above direction, this Writ Petition is disposed of. No costs. Consequently, connected miscellaneous petitions are closed.
