By this Writ Petition, the petitioner seeks a direction for the disbursement of appropriate compensation to him and his sister for the acquisition of the land in survey No.226/1A and 1B to the extent of 1 acre and 35 cents.

He has placed on record a copy of the Notification under subsection (1) of Section 4 of the Tamil Nadu Acquisition of Land for Adi Dravidar Welfare Schemes Act, 1978. 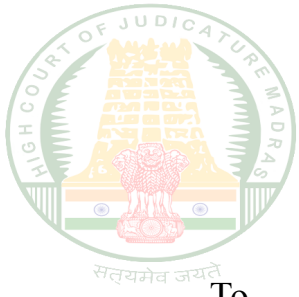
3. Learned counsel for the petitioner submits that the compensation mentioned therein is grossly inadequate. He seeks leave to challenge such order.

Otherwise, it is open to them to challenge such order in accordance with law.
