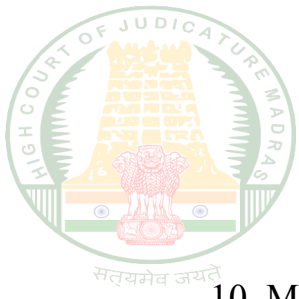

A speaking order shall be issued within three (3) months from the date of receipt of a copy of this order. No costs.
