2.Heard the learned Additional Government Pleader for the petitioners. Though notice has been served on the respondent, none appeared on her behalf.

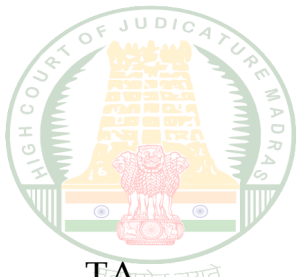
3.Being satisfied with the reasons stated in the affidavit filed in support of this petition, this Court is inclined to condone the delay of 107 days, however, on payment of costs.
