ORDER : The Court made the following order :-

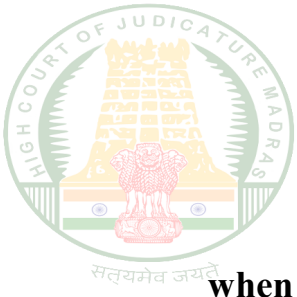
This petition has been filed to relax the condition imposed on the petitioners in Crl.O.P.(MD).No.13168 of 2025 dated 06.08.2025.
