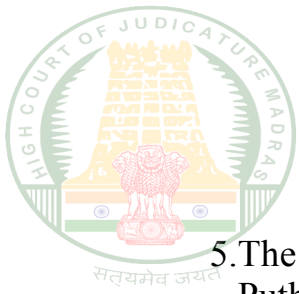

The third respondent is directed to enter the names of the writ petitioner's daughters in the register maintained by him and also issue revised certificate as sought for by the writ petitioner in his representation dated 23.09.2025. This shall be done immediately and without delay.
