2. Mr.S.Ananthi states that the parties stand by the settlement entered into before the Mediation on 04.04.2025.

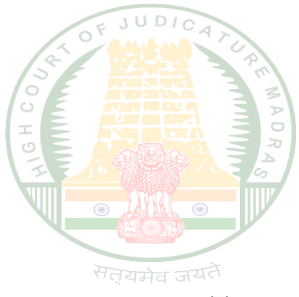
