3. The petitioner herein has filed the Contempt Petition on the ground that the land belongs to him and that the officials concerned are attempting to demarcate the land and conduct an enquiry in violation of the orders of this Court.

4. In case of any rival claims, the parties are at liberty to seek their remedies before the Civil Court. Similarly, if the petitioner is aggrieved by the conduct of the survey, he may approach the Civil Court for appropriate relief, including an injunction.

5. With the above observations, this Sub-Application stands disposed of. Consequently, Cont.P.(MD)SR.No.84205 of 2025 is rejected.
