ORDER

2. The learned counsel appearing for the petitioner would submit that the petitioner has given a representation on 06.12.2023 for alteration of Field Map Sketch. However, the same is yet to be considered. Hence, the Writ Petition.

3. The learned Government Advocate appearing for the respondents 1 to 5 would submit that the representation submitted by the petitioner will be considered within the time stipulated by this Court.

In view of the same, without expressing any opinion on the merits of the matter, this Court directs the respondents 2 to 5 to consider the representation of the petitioner dated 06.12.2023 and dispose of the same, on its own merits and in accordance with law, within a period of four (4) weeks from the date of receipt of a copy of this order.
