**ORDER**

Heard both sides.

The order impugned in the writ petition will be put on hold and kept in abeyance for a period of three months. It is for the writ petitioner to obtain an interim order before the Commissioner, HR&CE Department. The merits of the matter have not been gone into. Any interim application filed by the petitioner will have to be disposed of within a period of eight weeks,



thereafter. This writ petition stands disposed of accordingly. No costs. Consequently, connected miscellaneous petition is closed.
