ORDER

The present Writ Petition has been filed for a writ of Mandamus to direct the respondents to disburse the petitioner's difference amount of Salary, Gratuity, Surrender Leave, Provident Fund, Pensions Arrears and to revise pensions on the basis of 12(3) Settlement dated 31.05.2025 along with 6 percent interest.

2. The learned counsel for the petitioner submits that the issue raised in this writ petition is covered by an earlier order passed by this Court and has placed reliance on the order made in W.P(MD)No.20522 of 2025 dated 29.07.2025.
