ORDER

By relying on a sale deed dated 19.10.2001 and patta No.1276, the petitioner had applied online for the conduct of a survey. The present Writ Petition relates thereto.

2. Learned counsel for the petitioner submits that there is no rival title claim, but that owners of neighbouring lands are impeding the conduct of a survey.

3. Learned Special Government Pleader accepts notice on behalf of the first respondent and learned Government Advocate (Crl.Side) accepts notice on behalf of the second respondent. Learned Special Government Pleader submits that the petitioner's application would be acted upon after issuing notice to owners of all relevant adjacent lands.

3. The petitioner has placed on record both title and revenue records in his name. Consequently, a case is made out to consider the petitioner's request for a survey. Accordingly, this Writ Petition is disposed of by directing the first respondent to initiate action on the

petitioner's application and take all necessary steps in relation thereto within three (3) months from the date of receipt of a copy of this order after issuing notice to owners of relevant adjacent lands. If necessary, the revenue officials may take the assistance of the jurisdictional police. No costs.
