### **ORDER**

This Writ Petition has been filed to direct the respondents to disburse the compensation amount of Rs.20 Lakhs for sewer death of the petitioner's son to the petitioner as per the Judgment of the Apex Court in W.P. (Civil)No(s).324 of 2020 dated 01.02.2023, on the basis of the petitioner's representation dated 08.11.2023.

2. The learned counsel appearing for the petitioner would submit that the petitioner has given a representation on 08.11.2023 for disbursal of the compensation amount of Rs.20 Lakhs for the sewer death of his son, to him. However, the same is yet to be considered. Hence, the Writ Petition.
