ORDER

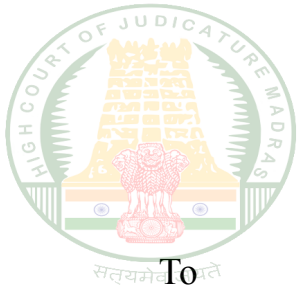
By this writ petition, the petitioner seeks a direction for the transfer of the patta in relation to several survey numbers in the name of the petitioner and her sister Deivanayagi.

3.On perusal of paragraph No.6 of the affidavit, it appears that pattas have been issued in the names of several individuals. Therefore, the request of the petitioner cannot be entertained unless the petitioner challenges the orders granting pattas to the third parties. By leaving it open to the petitioner to file an appeal before the Revenue Divisional Officer challenging such pattas, this writ petition is disposed of without any order as to costs.
