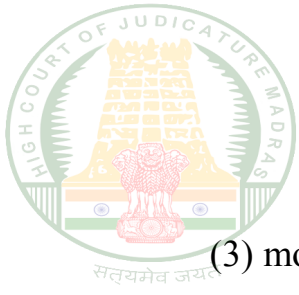

ORDER

He submits that the matter is pending consideration by the Revenue Divisional Officer and that the petitioners' request would be disposed of on merits within three (3) months from the date of receipt of a copy of this order.

3. In the above circumstances, without making any observations on the merits, this Writ Petition is disposed of by directing the second respondent to consider and dispose of the petitioners' request for patta in respect of lands in survey No.399/21 of the extent of 5 ares within three
