This case came up for settlement before the Lok Adalat. Both the parties present. The counsel for the appellants Mr.J.S.Murali and the counsel for the first respondent Mr.D.Gershon Gnanapaul for Mr.M.Jerin Mathew are present. After mutual discussion, negotiation, mediation and conciliation between both parties and with the assistance of the Bench, both sides consented for settlement.

AWARD

Both the parties and their respective counsel are present and they arrived at an amicable settlement for a sum of Rs.25,50,000/- [Rupees Twenty Five Lakhs and Fifty Thousand only] as full quit.

2.It is submitted that Rs.13,39,709/- [Rupees Thirteen Lakhs Thirty Nine Thousand Seven Hundred and Nine only] has already been deposited before the Tribunal by the appellants. The



appellants are directed to deposit the remaining amount within a period of four [4] weeks from deposit, the claimant/ first respondent is permitted to withdraw the entire amount, less already withdrawn, on filing proper petition before the Tribunal.
