PRAYER:-Writ Petition, filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the respondent to pay the petitioner interest at the rate of 18 percent per annum, for the period of delay from 01.05.24 to 24.08.25, in paying the amounts paid towards his terminal and pension benefits namely EPF Employees Contribution, Gratuity, Encashment of Leaves and Commutated Value of pension within a time frame as may be fixed by this court.

ORDER

This writ petition has been filed for a writ of Mandamus to direct the respondents to pay the petitioner interest at the rate of 18% per annum, for the period of delay from 01.05.2024 to 24.08.2025, in paying the amounts paid towards his terminal and pension benefits namely EPF Employees Contribution, Gratuity, Encashment of Leaves and Commuted Value of pension.

2. Considering the admitted fact that there has been a delay in payment, the petitioner is entitled to statutory interest as provided under law.

3. Learned counsel for the petitioner would restrict his claim of interest at the rate of 6% per annum.

The respondents are directed to pay interest at the rate of 6% per annum on the belated terminal benefits payable to the petitioner from the date of his entitlement till the date of his payment within a period of twelve weeks from the date of receipt of a copy of this order.
