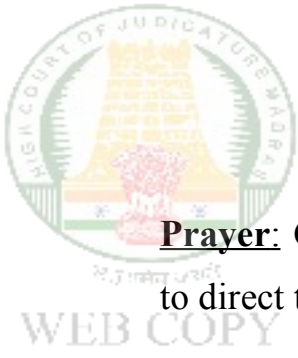

ORDER

2.
