ORDER

This writ petition has been filed for a writ of Mandamus, directing the respondents to settle the interest at the rate of 6 percent per annum for the belated payment of petitioners terminal benefits including Gratuity, Provident Fund, Current Leave Salary, and RBSR full amount from the date of the petitioner's retirement to till the date on which the said benefits were settled to him.

2. Considering the admitted fact that there has been a delay in payment, the petitioner is entitled to statutory interest as provided under law.

3. In view of the same, the writ petition stands disposed of. The respondents are directed to pay interest at the rate of 6% per annum on the belated terminal benefits payable to the petitioner from the date of his
