ORDER

By relying on Will bearing Document No.49 of 2006, dated 30.10.2006, the petitioner had applied for issuance of patta in respect of 2352 square meters in Survey No.261/30.

2. Learned Government Advocate accepts notice for all the respondents. On the basis of written instructions, he states that 1011 square metres in Survey No.261/30 was conveyed to one Ponnudurai under Document No.1278 of 1960. He also submits that the land is classified in the revenue records as 'Natham Sarkar Poramboke vacant land'. He also points out that the petitioner has put up a construction in the last one year. He submits that an order would be issued within three months after issuing notice to the petitioner and to Ponnudurai.
