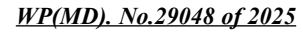

PRAYER :- Writ Petition, filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus directing the respondents to pay the petitioner interest at the rate of 18 percentage per annum for the period of delay from 01.03.2024 to 24.08.2025 in paying the amounts paid towards the terminal and pension benefits namely EPF Employees contribution Gratuity and Commutated Value of pension of her deceased husband /retired employee (Late) A. Mariappan staff No. 5182 within a time frame as may be fixed by this Court.

This writ petition has been filed for a writ of Mandamus to direct the respondents to pay the petitioner interest at the rate of 18 % per annum for the period of delay from 01.03.2024 to 24.08.2025 in paying the amounts paid towards the terminal and pension benefits namely EPF Employees contribution Gratuity and Commutated Value of pension of her deceased husband /retired employee (Late) A. Mariappan staff No. 5182.

2. Considering the admitted fact that there has been a delay in payment, the petitioner is entitled to statutory interest as provided under law.

3. Learned counsel for the petitioner would restrict his claim of interest at the rate of 6% per annum.
