ORDER

This writ petition has been filed seeking direction to the Respondents to pay the interest at the rate of 18 percentage per annum for the belated payment of retirement benefits including, Provident Fund, Earned Leave encashment along with interest.

2. Considering the admitted fact that there has been a delay in payment, the petitioner is entitled to statutory interest as provided under law.

3. The learned counsel for the petitioner would restrict his claim of interest at the rate of 6% per annum.
