ORDER

This writ petition has been filed for a Writ of Mandamus directing the respondent to pay the petitioner interest at the rate of 6 percent per annum, for the period of delay from 01.01.24 to 24.08.25, in paying the amounts paid towards his terminal benefits namely EPF Employees Contribution, Gratuity, Encashment of leaves/Already Surrendered Earned Leaves and Commutated Value of Pension.

2. Considering the admitted fact that there has been a delay in payment, the petitioner is entitled to statutory interest as provided under law.
