She had already filed D.V.C.No.4 of 2025 on the file of the learned Judicial Magistrate, Aalangudi under the provisions of Protection of Women from Domestic Violence Act, 2005. However, a residential order does not appear to have been obtained. The petitioner will have to necessarily
