This writ petition has been filed for the following relief :

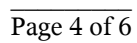
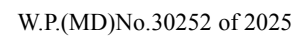

When the matter is taken up for hearing today, the learned Additional Government Pleader on instructions would submit that the crematorium is proposed to be put up in Survey No.1349 which is the blue coloured portion in the sketch filed along with the report and not in the petitioner's land which is coloured in red, bearing Survey No.1347. The report would also state that there are four bodies which have been buried in the petitioner's patta land. The sketch circulated by the learned Additional Government shall form part and parcel of the order and the same is extracted as follows:
