This writ petition has been filed for a writ of Mandamus, to direct the respondents to pay the 6% interest on the delayed payment of Commutation amount of Rs.14,54,228/- paid to the petitioner, from the date of his retirement on VRS i.e., 31.03.2022 to actual payment made on 13.03.2023.

2. Considering the admitted fact that there has been a delay in payment, the petitioner is entitled to statutory interest as provided under law.

3. In view of the same, the writ petition stands disposed of. The respondents are directed to pay interest at the rate of 6% per annum on the belated terminal benefits payable to the petitioner from the date of his entitlement till the date of his payment within a period of 12 weeks from the date of receipt of a copy of this order.
