ORDER

The petitioner, who is the mother of the detainee, filed this petition to produce her daughter namely Bhuvaneswari before this Court.

2.The petitioner being the mother of the detainee lodged a complaint before the 1st respondent alleging that her daughter was missing from 01/08/2025. On receipt of the complaint from the 1st respondent, the 2nd respondent registered a case in Crime No.321 of 2025 under 'Women Missing'. Since, no action has been taken by the 2nd respondent police, the petitioner is constrained to file this petition,

3.Pending this petition, the 2nd respondent found the detainee and produced before this Court. On enquiry by this Court, she would state that she on her own volition went to Tirupur and working there, due to misunderstanding between herself and her husband. She would further state that the petitioner also compelled her to go to her husband's house and now, she wants to stay with the petitioner.
