ORDER

The petitioner asserts that the property in survey No.810/2 stood in the name of his father, Abdul Hameed, and that such patta was wrongly mutated in the name of his sister-in-law, the third respondent herein. After submitting a representation to the Tahsildar in this regard, the present Writ Petition has been filed.

2. Learned Additional Government Pleader accepts notice on behalf of respondents 1 and 2. He submits that an inquiry is ongoing and that orders would be issued by the Revenue Divisional Officer within two (2) months from the date of receipt of a copy of this order, after providing a reasonable opportunity to the petitioner and the pattadar.

3. In view of the above submissions of learned Additional Government Pleader, it is unnecessary to issue notice to the third

respondent in this Writ Petition. Instead, this Writ Petition is disposed of, without making any observations on the merits, by directing the first respondent to conduct an inquiry, provide a reasonable opportunity to the petitioner and the third respondent and, thereafter, issue a speaking order within two (2) months from the date of receipt of a copy of this order.
