ORDER

This writ petition has been filed for a writ of Mandamus, to direct the respondents to pay the petitioner interest at the rate of 18% per annum, for the period of delay from 01.01.24 to 24.08.25, in paying the amounts paid towards his terminal and pension benefits namely EPF Employees Contribution, Gratuity, Encashment of leaves and Commutated Value of Pension.

2. Considering the admitted fact that there has been a delay in payment, the petitioner is entitled to statutory interest as provided under law.

3. Learned counsel for the petitioner would restrict his claim of interest at the rate of 6% per annum.
