To relax the condition imposed upon the petitioner in CrI.O.P(MD) No.14050 of 2025 dated 25.08.2025 that the petitioners shall appear before the respondent police daily at 10.30 am until further orders and thus render justice.

ORDER : The Court Made the following order :-

Heard.

2. The learned Government Advocate (Criminal Side) submitted that except the 5<sup>th</sup> petitioner all other petitioners have been complying with the condition regularly. He further submitted that 5<sup>th</sup> petitioner / accused complied with the condition only for 10 days and hence, he vehemently opposed for granting relaxation of the condition to the 5<sup>th</sup> petitioner.

3. The learned counsel appearing for the petitioners submitted that 5<sup>th</sup> petitioner is a student and hence, he is not able to comply with the condition regularly.

4. Considering the nature of offence and also considering the fact

that the 5<sup>th</sup> petitioner is a student, the condition imposed by this Court in Crl.O.P(MD) No.14050 of 2025, dated 25.08.2025 is relaxed and the petitioners shall report before the respondent police as and when required for interrogation.

5. Accordingly, this Criminal Miscellaneous Petition is allowed.
