PRAYER: Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus to direct the respondents to rectify the UDR error made in Survey Nos. 706/2, 747/7, 808/4, 818/3, 1, 1129/6, 705/7, 5, 10, 768/1, 781/5, 787/2, 788/2, 789/1, 2, 3, 6, 799/3 and 801/7 situated at Senthurai village, Natham Taluk, Dindigul District, based on petitioner's representation dated 23.04.2025 within the stipulated time as fixed by this Court.

ORDER

After submitting a representation dated 24.03.2025 to the District Revenue Officer complaining of a UDR error in issuing patta in the name of one Muthunaickar, the petitioner seeks the early disposal of such representation.

2. Learned Government Advocate accepts notice for all the respondents. He points out that the Revenue Divisional Officer has called upon the Tahsildar to provide a report in relation to the petitioner's representation. He submits that a speaking order would be issued by the second respondent within three (3) months from the date of receipt of a copy of this order.

3. From the affidavit in support of this Writ Petition, it appears that the patta was issued in the name of one Muthunaickar. Therefore, before

taking a decision, it is necessary that the pattadar be heard.
